The Union of BC Municipalities (UBCM) has struck a Special Committee that is exploring the supply and demand side of the housing equation, including areas of voluntary local government action and collaboration with the senior orders of government, in order to identify actions that will make housing more affordable for people who live, work and contribute to BC's communities. Summer 2017 was officially the worst ever wildfire season in BC history. The coverage and the devastation is unprecedented and the wildfire response was a match in size, scope and complexity. This session will feature a multi-sector panel of representatives from one of the worst hit areas of the province as they discuss their experiences on the ground and what they learned from the highs and lows of coordinating firefighting and evacuations. Join the discussion and gain a better understanding of how local governments can work together with their neighbours and with supporting agencies to minimize damage, ensure public safety, and navigate the challenges of recovery after a wildfire emergency.
