Conflict of Interest - Continued

- Disqualification from voting
 - Bias/reasonable apprehension of bias
 - Richmond; St. Boniface
 - Personal interest client, family, patient, contractor, close friend and political agent.
 - L'Abbee case
- s. 122 <u>Criminal Code</u> fraud/breach of trust
- Participation on other societies or entities

Gifts

- Community Charter s. 105 prohibition
- Disqualification from office
- Exceptions
- Incident of protocol/social obligations
- Compensation
- Lawful campaign contribution
- First exception subject to disclosure if over \$250

Personal Liability

- Case law and statute
- Statute
- s. 287 LGA immunity for individual municipal officers
- Removes liability
- Municipality is vicariously liable
- Exceptions gross negligence, misconduct, defamation

Personal Liability (c'd)

- s. 287.2 LGA indemnification against proceedings:
 - ad hoc resolution
 - indemnification bylaw
 - insurance
 - exceptions:
 - Fine for offence (unless strict liability offence)
 - Dishonesty, gross negligence, malicious or wilful misconduct
 - * s. 191 Community Charter*
