ATR policy

Fills legislative gap

Outlines conditions for adding land to reserve

ATR policy review

Initiated in 2011 by Aboriginal Affairs and Northern Development (AANDC) and Assembly of First Nations (AFN)

Additions to Reserve: Expediting the Process

Released by Standing Senate Committee on Aboriginal Peoples in 2012

- Reconciliation Week coincides with 2013 UBCM Convention
- UBCM assembly declares
 Year of Reconciliation
- UBCM offers Expression of Reconciliation at Truth and Reconciliation Commission National Event

UBCM Declares Year of Reconciliation with BC First Nations

Sep 18, 2013

UBCM delegates started UBCM convention by adopting a resolution to declare a year of Reconciliation with First Nations across British Columbia.

The wording of the resolution is as follows:

WHEREAS the Truth and Reconciliation Commission of Canada, with the support of Reconciliation Canada, have announced that its National Event for BC take place in the City of Vancouver from September 16 to 22, 2013; and

WHEREAS the Union of British Columbia Municipalities has actively engaged with First Nations communities and peoples through the work being done by its own First Nations Relations Committee; and

WHEREAS the City of Vancouver, the host community for this year's Union of British Columbia Municipalities Annual Convention, and many other communities have declared this year to be their Year of Reconciliation with First Nations peoples and communities; and

WHEREAS making such a commitment is the first step in fostering a new relationship based in respect and honesty,

BE IT RESOLVED that the Union of British Columbia Municipalities also declare this year, 2013, as its year of Reconciliation with First Nations across British Columbia.





Local Government Elections

Phase 1

- Accountability, transparency, compliance and enforcement
- Everything but expense limits
- If passed by Legislative Assembly, would take effect for November 2014 local elections

Phase 2

- Expense limits
- Legislation perhaps introduced soon after 2014, well in advance of next local elections



Local Government Elections

Next Election November 2014; move to third week in October after 2014

Request for 4 year terms



Building Canada Fund

Program Details Unknown

- FCM meeting with Federal Ministers, but still no answers
- UBCM less directly involved in discussions

Local Government Access a Priority

 Allocation of funding to local governments (e.g. through Communities Component) will be key and is not yet assured

May know more by Budget Date

• FCM anticipates more detail will be announced before federal budget day (Feb 11)
