Join Mayor Malcolm Brodie, Chief Wayne Sparrow and LGLA President, Chair Rhona Martin as they officially open the 2016 Forum.

#### Keynote Address: 3-Dimensional Leadership, Dr. Beverley Busson, OBC (1:45-3:00 pm)

The truth is that nothing meaningful can ever be achieved in the workplace without mutual respect: respect for yourself, respect for others and respect for the organization and its goals. Despite the need for transparency and oversight, successful leadership at any level cannot be achieved without this essential 3-dimensional foundation. Bev will explore this imperative from her own perspective and experience through her 33 years of policing, beginning as an RCMP constable, through her time as the Commanding Officer of British Columbia to Commissioner of the RCMP.

Beverley Ann Busson, C.O.M., O.B.C., LLB., LLD.UCFV, LLD.SFU(Hon) never imagined that her decision to join the RCMP back in 1974 as one of the first female members would lead her to becoming one of Canada's most powerful women; and would allow her to experience a career marked with trail blazing success stories and such incredible challenges along the way. Not only was Bev one of the first women to join the RCMP but she was also the first woman to be appointed to the position of Commanding Officer of a Province, the first woman to be appointed as Commissioner of the RCMP and the first police officer to ever be awarded the Order of British Columbia.

Bev offers her comments and advice on how to navigate the workplace from the bottom up. She has lessons to pass on from the unique perspective of a woman employed in a male dominated working environment and in strategically leading a complex and dynamic organization. Her remarks are sprinkled with stories and anecdotes about her own experiences, some humorous and some serious, but all of them designed to have her audience lean in to her inspiring message.

#### Introduction of Forum Rapporteur, Ken Cameron (3:00-3:10 pm)

Forum Rapporteur, Ken Cameron, will attend sessions and networking events and interact with speakers and delegates in order to provide participants with a summary of topics covered and discussions held over the course of the Forum. With the Forum theme and streams in mind, he will provide delegates with some take-away insights and observations to share with their councils and boards back home.

### Community Engagement Workshop, Shauna Sylvester, Robin Prest, Sebastian Merz & Jenna Dunsby (3:30-5:00 pm)

Elected officials want to hear from citizens who are informed about the issues, understand real world trade-offs, and reflect the views of the general public rather than the "same ten people." Citizens in turn wish to know that engagement is more than lip service, and to have certainty that their input will tangibly impact decisions that affect them. Yet real world engagement processes often fall short from these ideals, leading to frustration and distrust.

Useful and authentic engagement experiences are possible, but require up-front effort to define how public input fits within the larger decision-making process. Hosted by the Civic Engage program at Simon Fraser University's Centre for Dialogue, this interactive session will explore four key questions Council must discuss with its CAO to enable high quality public engagement: What is the purpose of public engagement and how does this add value to the decision-making process? What constraints will limit the scope of public input? How will the role of the public relate to the roles of elected officials, staff, and experts? And what is your contract with the public, so that the process builds trust and mutual accountability?

MLA Selina Robinson will address delegates in her capacity as Opposition Spokesperson for Local Government and will join us for the Networking Reception beginning immediately afterward.

#### UBCM Early Morning Clinic - Asset Management: More Than Just a Gas Tax Requirement, Glen Brown (7:15-8:15 am)

Communities build and maintain infrastructure to provide services. These services support our quality of life, protect our health and safety, and promote social, economic and environmental well-being. Failure to care for our infrastructure, manage our natural resources and protect the benefits provided by nature risks degrading, or even losing, the services communities enjoy, and that future generations may rely on.

Asset Management for Sustainable Service Delivery: A BC Framework (the Framework) establishes a high-level, systematic approach that supports local governments in moving toward service, asset and financial sustainability through an asset management process.

This session will provide an overview of asset management and the approach within BC, highlight the Framework, identify how asset management has been integrated/required under senior government capital funding programs such as the Gas Tax Fund, and discuss the importance of asset management as a strategic priority for local governments.

Local Governments and First Nations have a unique opportunity to make reconciliation a priority, to open the dialogue and begin to explore a New Way Forward with the neighbouring municipality or nation.

### 3) Respect for the Office - Elected/Elected/Staff Relations, Allison Habkirk, Linda Adams, Gord Horth, Christina Benty

We have all seen communities get caught in a cycle of conflict at the council table or with staff and how that conflict gets in the way of getting the business of the community done. Respecting the office and building constructive relationships with other elected officials and staff will help make you more successful as an elected official and help you accomplish your goals while in office.

Join Christina, Gord, Linda and Allison (who have over 100 years of collective experience in local government) in an engaging and interactive session that will help you avoid getting caught in the conflict cycle and instead lead your council or board and staff to build positive and productive relations.

### 1) Respect for Yourself - Self Leadership: Using Olympic Principles to Guide Your Personal Success, Dr. Jennifer Walinga

Self Leadership is about understanding and managing the complex, multiple facets of your self. The metaphor of sport is a powerful example of how optimal performance depends on identifying and leading from your personal strengths. The sport metaphor is often used to describe management and leadership practices. Teamwork, visioning, strategy, and training parallel sport performance. In this session, an Olympic rower will demonstrate how productive the leadership/sport metaphor can be for self leadership, personal development and performance.

Drawing on her experience as a two time Olympian, and particularly as a member of Canada's double gold medal winning Olympic rowing team (Barcelona 1992), Dr. Jennifer Walinga shows participants how the sport performance metaphor can be applied effectively to the practices of self leadership: goal setting, visioning, and planning. In her 25 years as an educator, researcher and consultant in the area of organizational behaviour and learning, Walinga has seen how successfully the tools she learned in the rowing shell transfer to daily life. Jennifer weaves colourful stories and videos throughout her presentation and includes an interactive component that shows how physiological principles are just as present at work as they are in sport.

#### 2) Respect for Others - Effectively Managing Meetings and Encounters with the Public, Christina Benty, Frank Leonard, Jordan Bateman, Councillor Caleb Moss

Good governance does not happen by default, it happens by design. Effective meetings are intentional, not accidental. Everyone wins when good process is practiced and functional relationships exist between elected officials, staff and the community. Learn from both the mistakes and the successes of political veterans as they explore some common pitfalls that diminish the effectiveness of governing bodies. They will teach you how to get the most out of your meeting time by sharing stories and answering questions in an entertaining and interactive session. Plan to leave with some tips, tools, and workable solutions to successfully manage meetings and interactions with the public.

### 3) Respect for the Office - Conflict Engagement & Communications Skills & Tools Workshop, Michael Shoop & Gerrie Waugh

This workshop will focus on skills and tools that will enable elected officials to engage conflict in various settings. Facilitated by two conflict management and communications professionals, the session will be highly interactive – including role-playing, scenario-based examples and hands-on learning methods.

Conflict and communications skills and tools covered can be used in situation such as:

- Conflict at the council table and in committee sessions;
- Conflict with senior staff members:
- Conflict with the public in the council chamber; and
- Conflict with the public away from the council chamber (e.g., on the street, on the telephone).

The objective of the session is to build better relationships with fellow councillors, senior staff and the public.

### Evening Plenary – CIVILITAS: Respectful Leadership – Your Personality Impact on Others, Dr. Gordon McIntosh (7:00-9:00 pm)

Every personality style can be a contributor or inhibitor to civic relationships and processes. Join Dr. Gordon McIntosh for an interactive and engaging session on respectful leadership. Learn personal strategies and organizational practices to enhance civility in political and administrative relations.

#### 1) Harassment/Bullying/Bill 14, Kacey Krenn & Scott McCann, Harris & Co.

Employers have a duty to protect their employees from workplace bullying and harassment, and this policy impacts the public sector as well as the private. In this session, Kacey and Scott will educate elected officials and senior government staff on the implications of Bill 14, while exploring some of the Do's and Do Not's of appropriate behaviour within a government landscape.

#### 2) Open Meetings, Linda Blackman & Charisse Giarraputo, BC Office of the Ombudsperson

Most local government meetings are to be open to the public. *Open Meetings: Best Practices Guide for Local Governments* helps local councils and boards ensure meeting standards and practices demonstrate openness, transparency and accountability to the public. The report includes a checklist to assist local governments in the limited circumstances where a meeting may be closed.

#### 3) Is there a role for an Integrity Commissioner? Reece Harding, Young Anderson

This discussion examines the current legislative vacuum in British Columbia in dealing with an elected official's misconduct. The discussion then reviews Integrity Office models in other Canadian provinces and takes a look at what type of model could be tailored to suit the needs of BC local governments.

#### 1) Reconciliation in Action: TRC 94 Calls to Action, Marissa Lawrence, Reconciliation Canada

What is the role of Local Government in reconciliation for Indigenous peoples and all Canadians? In June 2015, the Truth and Reconciliation Commission of Canada released 94 Calls to Action. Municipalities and Local Governments are called upon in a number of the Calls to Action, namely to adopt and implement the United Nations Declaration on the Rights of Indigenous Peoples, and to provide education to public servants on the history of Aboriginal peoples in Canada.

Reconciliation Canada will highlight three municipalities and municipal service providers who have made great progress through small and achievable reconciliation action.

### 2) Freedom of Information & Protection of Privacy: What Every Elected Official Needs to Know, Dr. Jay Fedorak, Office of the Information & Privacy Commissioner for BC

A practical guide for all elected officials on the privacy, access to information and records management requirements of the *BC Freedom of Information and Protection of Privacy Act*. It covers all of the essential steps, illustrated by examples, which elected officials should take to ensure that they and their municipalities remain in compliance. There is growing public awareness of privacy and access to information issues. Reduce the risk that you or your municipality will have to manage avoidable issues.
