## **Economic Recovery – Large and Small Communities Under Pressure**

The need for economic recovery and transformation is a reality for all communities, large and small. How to adapt, attract new businesses and workers, keep vibrant centres are universal challenges and keys to economic resilience.

In part I, **George P. Richard Benson, Manager, Economic Transformation, Vancouver Economic Commission** will be introducing some new trends and key elements to implementing and sustaining a new economic vision for a community. In part II, LGLA Board members **Laurey-Anne Roodenburg (Councillor City of Quesnel)** and **Curtis Helgesen (CAO of Bulkley Nechako)** will call on real life examples, introducing case studies from small/mid-sized communities that have executed successful transformations with a new approach to their economic development, notably **the Village of Canal Flats**. From mill closure in 2015 to 22% population growth from 2016-2021, Canal Flats did not accept fate; the community is proactively and ambitiously shaping a vision-based destiny...road-bumps and great achievements included. Presenting for Canal Flats, is **Chris Fields of Rynic.org**. Chris has 30 years of experience in government, not-for-profit, and enterprise settings that demonstrates strategic marketing, leadership capacity building, and collaborative strategic pathways development expertise. Chris has served as a contract Economic Development Officer for the Village of Canal Flats since mill closure in 2015.

## **Impacts of Climate Change - What Is an Emergency?**

Failure to maintain cyber security infrastructure can have significant impacts on a local government. Cyber security breaches give rise to a number of privacy issues, and trigger various obligations under the Freedom of Information and Protection of Privacy Act. In addition, where a third party suffers a reasonably foreseeable loss as a result of a cyber security breach, the actions of the local government involved may be the subject of a claim in negligence. This session will canvas the privacy issues raised by a cyber security breach in the context of local government obligations to safeguard personal information, then canvas the liability issues raised by such a breach.
